Reserve Bank of India

- The Reserve Bank of India (RBI) has shared details on India's International Investment Position (IIP) at the end of December 2022.
 - According to the data, non-residents' net claims in India **dropped** by **US\$ 12.0 billion** between October and December 2022, settling at US\$ 374.5 billion by the end of December 2022.
- The Reserve Bank of India has announced its bimonthly monetary policy and kept the **repo rate unchanged** at **6.50 per cent**.
 - GDP growth is expected to have been 7 per cent in FY 22-23.
- Several **public sector banks** in India have transferred a total of **Rs 35,012 crore** (\$4.7 billion) in unclaimed deposits to the Reserve Bank of India (**RBI**).
- The Reserve Bank of India (RBI) announced that it has imposed penalties on Mahindra & Mahindra Financial Services Ltd, Indian Bank, and Muthoot Money Limited for non-compliance with regulatory norms.
- RBI is set to introduce a new secured web-based portal called "PRAVAAH" (Platform for Regulatory Application, Validation And Authorization) aimed at simplifying and streamlining the application processes.
- The Reserve Bank of India (**RBI**) released comprehensive instructions for banks and non-banking financial companies (NBFCs) regarding the **acceptance** of 'green deposits'.

State Bank of India

- The State Bank of India (**SBI**) has revealed plans to introduce new variants of **current accounts** and **savings accounts** in the fiscal year 2023-24, as it seeks to reduce the gap between deposit growth and credit growth.
 - It also plans to introduce a new savings account called "Parivar" (family) account.
- State Bank of India (SBI) has announced the re-introduction of its retail term deposit scheme, Amrit Kalash.
 - The scheme offers a special tenor of 400 days and provides an interest rate of 7.6% for senior citizens and 7.1% for others.
- SBI opened its fourth branch exclusively for startups in Mumbai's BKC area.

Other Banks

- India Post Payments Bank (IPPB) launched its WhatsApp Banking Services in New Delhi.
- State-owned **Bank of Maharashtra** (BoM) has opened its first dedicated branch for **startups** in **Pune**, **Maharashtra**.
- Canara Bank and NPCI Bharat BillPay Ltd (NBBL) have collaborated to launch a service that allows Indians residing in Oman to make payments for their bills in India.

- City Union Bank Limited (CUB) has introduced a new feature that allows customers to use voice biometric authentication when logging into the bank's mobile banking app, aimed at improving security.
- **Jupiter**, a neobanking startup, has obtained a non-banking finance company (**NBFC**) **license** from the Reserve Bank of India (RBI), enabling the company to provide credit from its own resources.

• In a significant development, the Election Commission has granted **national party status** to the **Aam Aadmi Party** (AAP).

States

- The European Commission (EC) has awarded protected geographical indication (**PGI**) status to **Kangra tea**, a unique variety of tea grown in the Kangra district of India's **Himachal Pradesh**.
- Eravikulam National Park is located in the Western Ghats of India, in the state of Kerala.
 - In a first, Eravikulam National Park gets a **fernarium**.
- The Benarasi Paan, known for its distinct taste and unique blend of ingredients, has been awarded the GI tag along with three other Varanasi-based products: Banarasi Langda Mango, Ramnagar Bhanta (Brinjal), and Adamchini Rice.
- According to data shared by the GI Registry, **Kerala** (six products) has secured the highest number of Geographical Indication (**GI**) tags for products among all states in India in FY23.
- The **Mircha rice** variety from West Champaran district of **Bihar** has recently been granted the **GI** tag.
- Chhattisgarh's Nagri Dubraj, an aromatic rice variety, has been granted a geographical indication (GI) tag by the Geographical Indication Registry.
- The **Tamil Nadu** Industrial Development Corporation (**Tidco**) has developed a mechanism called Tamil Nadu Regional Aerial Connectivity through Helicopters (**TN REACH**), which aims to utilize over **80 unused helipads** across the state to provide intercity and town connectivity.
- The Chief Minister of **Maharashtra**, Eknath Shinde, has declared that May 28, the birth anniversary of freedom fighter Vinayak Damodar Savarkar, will be celebrated as 'Swatantrya Veer Gaurav Din'.
- **Himachal Pradesh** has initiated a project named **Sanjeevani** to uplift the livelihood of small dairy farmers and livestock owners.
- The well-known **Gond painting** of **Madhya Pradesh** has been granted the coveted Geographical Indication (**GI**) tag.
- **Kerala** adopts a **Water Budget** the first of its kind in the country.
 - The details of the first phase of the Water Budget in the state covering 94 grama panchayats in 15 block panchayats were unveiled by Kerala Chief Minister Pinarayi Vijayan.
- The famous **Cumbum Panneer Thratchai** or Cumbum grapes from **Tamil Nadu** have recently been granted the Geographical Indication (GI) tag.
- In a first-ever census of its kind in the country, forest officials in **Odisha's** Bhitarkanika have sighted 179 mangrove **pitta birds**, which are known for their exotic and vibrant colours.
- The **Rajasthan** government's recent declaration of **three areas** as **conservation reserves** has brought a ray of hope for wildlife conservation efforts and ecotourism in the state.
 - As the state government declared three areas Sorsan in Baran, Khichan in Jodhpur and Hamirgarh in Bhilwara as conservation reserves.

Defence and National Security

- The 10th annual SLINEX-2023 bilateral maritime exercise between India and Sri Lanka has commenced in Colombo, Sri Lanka.
- India's Sukhoi-30s, which are made in Russia, will participate in an exercise named 'Cope India' that involves dogfighting with American F-15 Strike Eagle fighter jets.
- On April 5, 2023, the **Andaman & Nicobar** command, which is India's sole tri-services unit, held a collaborative military drill named Exercise 'KAVACH'.
- The **Indian Air Force's Rafale** fighter jets will be participating in a military exercise in **France** that involves thousands of **NATO troops**.
- As part of her three-day official visit to the northeastern state, **President** Draupadi Murmu boarded a **Sukhoi 30 MKI** fighter jet for a flight from the strategic Tezpur Airforce station in **Assam**.
- The **INS Vikrant**, India's first indigenous aircraft carrier, was presented with a special gift in the form of its **original bell** from the first carrier of the same name commissioned in 1961.
- The **Greek** and **Indian Air Forces** will collaborate on a joint training exercise with Su-30, F-16, and Rafale fighter jets for ten days over **Greece** and the Mediterranean Sea.
- The inauguration of the Defence Research and Development Organization (**DRDO**) Industry Academia Centre of Excellence (**DIA-CoE**) took place at the Indian Institute of Technology-Hyderabad, making it the largest facility of its kind in the country.
- The 7th edition of the joint military exercise "AJEYA WARRIOR-23" is currently underway at Salisbury Plains in the **United Kingdom**.
 - This biennial training event with the United Kingdom alternates between the **United Kingdom** and **India**.

Committees/Commissions

- The **Indian** government has formed a committee to explore ways of enhancing the **pension** benefits of **government employees** under the National Pension System (**NPS**).
 - The committee will be headed by the finance secretary and consists of three other members.
- The government implemented changes to the pricing model of domestic **natural gas** in accordance with the **Kirit Parikh committee's** recommendations on gas pricing.

- The government has introduced a new program called the "New India Literacy Programme" (NILP), which is a Centrally Sponsored Scheme that will be implemented for five years from FY 2022-23 to 2026-27.

• The Central government has recently issued the **Animal Birth Control Rules**, 2023, which are designed to comply with the guidelines set by the Supreme Court in a writ petition involving the Animal Welfare Board of India (AWBI) and the People for Elimination of Stray Troubles.

Fund

- India gives \$2 million to African Union Transition Mission in Somalia.
- The Asian Development Bank (ADB) has announced its plans to invest in non-convertible debentures valued at Rs 150 crore in Tata Power Delhi Distribution Ltd (TPDDL).
- The Asian Development Bank (**ADB**) Annual Report 2022 revealed that **Pakistan** received loans of **\$5.58 billion**, making it the largest recipient of ADB-funded programs/projects in the year 2022.

Economy

- According to the Reserve Bank of India (RBI), India's foreign exchange reserves have continued to increase for the second consecutive week, reaching USD 578.778 billion in the week ending March 24. This indicates a rise of USD 5.978 billion in the week.
- The Controller General of Accounts (**CGA**) released data indicating that the central government's **fiscal deficit** reached **82.8**% of the full-year target at the end of February.
- The Reserve Bank of India (RBI) has released data showing that India's **current account deficit** has decreased to \$18.2 billion, which is equivalent to 2.2% of the GDP.
- The Goods and Services Tax (**GST**) **revenue** collection for March 2023 has increased by **13**% to Rs 1.60 lakh crore, according to data released by the Ministry of Finance.
- According to a recent report by the World Bank, **India's GDP** growth is predicted to slow down on April 1 to **6.3**% from 6.6% in the fiscal year 2024.
- The Unified Payments Interface (**UPI**), India's flagship digital payment platform, set a new record at the end of the fiscal year 2022-23.
 - In March 2023, the UPI processed a historic high of **8.7 billion transactions**, worth Rs 14.05 trillion.
- According to the latest **ADB** outlook, **India's economic growth** rate is expected to reach **6.4**% in 2023-24 from 6.8% in FY23, while the growth forecast for the current year has been revised downwards to 6.4% from 7.2% earlier projected.
- In a recent address to the Indian diaspora community in France, Union Minister Piyush Goyal announced that **India** is set to become the **third-largest economy** in the world by **2027**.
- The International Monetary Fund (**IMF**) has revised **India's** Gross Domestic Product (**GDP**) growth forecast for the financial year 2023-24, lowering it by 20 basis points to **5.9 percent**.
- As per the latest Trade and Development Report Update released by the United Nations Trade and Development Conference (UNCTAD), India's economic growth is expected to slow down from 6.6% in 2022 to 6% in 2023.
 - The report also predicts a **decline** in **global growth** in 2023 to **2.1**% from the previously projected 2.2% in September 2022.
- According to the NSO data, **India's** annual **retail inflation** for March eased to **5.66**% from 6.44% in February.
- India's wholesale-price based inflation eased in March 2023, as input prices continued to moderate.
 - The annual wholesale price inflation (WPI) was recorded at **1.34**% year-on-year, which is a significant decrease from the previous month's reading of 3.85%.

Companies/Industry

- Walmart-backed Indian fintech decacorn **PhonePe** has recently launched **Pincode**, a new consumer-facing app aimed at strengthening its e-commerce initiatives.
- WhatsApp has initiated a safety campaign called 'Stay Safe with WhatsApp' aimed at educating users about the product features that can assist them in maintaining their online safety and improving their messaging experience.
- The authorities of the **Nagarjunasagar-Srisailam Tiger Reserve** and the **NHAI's** subsidiary, Indian Highways Management Company, signed an agreement aimed at streamlining the entry process for vehicles into the forest area.
 - MoU will enable the implementation of a FASTag-based payment system at forest entry points.
- Apple opened its first official store in Mumbai, India.
- The city of **Ayodhya** has been chosen for a two-year pilot project aimed at producing **biodiesel** from waste.
 - **Belgium**-based company **Vito** is expected to launch the project in Ayodhya soon.
- The state-owned railway company **Rail Vikas** Nigam Limited (RVNL) was in focus as the Indian Government upgraded its status to a 'Navratna' Central Public Sector Enterprise (CPSE) from a 'Miniratna' category.

Exports/Imports

- India's gold imports have declined by about 30% to \$31.8 billion during April-February 2023.
- According to recent figures released by the Indian Ministry of Commerce, the **UAE** remains the **second** most significant **export** destination for India.
 - The **US** and **UAE** held onto their first and second positions, respectively, during the financial year 2022-23.

Taxation/Trade

- The government introduced the **Foreign Trade Policy** (FTP) 2023, which aims to increase the country's **exports** to **USD 2 trillion** by **2030**.
- **UK** is set to join the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (**CPTPP**), which covers a market of around 500 million people with a combined GDP of £9tn.
 - The CPTPP agreement was signed by 11 countries, including Canada, Japan, Mexico, and Australia, and came into force in December 2018.
- The Ministry of External Affairs declared that trade between **India and Malaysia** can now be conducted using the **Indian Rupee** (INR) as a mode of settlement, in addition to other currencies.
- World Trade Organization (WTO) has raised its projection for global trade growth in 2023 from 1% to 1.7%.
- NSE Indices Limited introduced the Nifty REITs & InvITs Index, the first of its kind in India, designed to monitor the performance of publicly listed and traded Real Estate Investment Trusts (REITs) and Infrastructure Investment Trusts (InvITs) at the National Stock Exchange, whether listed or unlisted but authorized to trade.
- The potential signing of a free trade agreement between **India** and the **European Union** is seen as a positive step towards promoting economic ties between the two regions.
